**2. Nature of Relationship:**

This MOU is for collaboration between both parties, for mutual benefit.

**Benefits to Government Polytechnic Sonepur Students:**

- Brings about enhancement in the overall Quality of the students.
- Enhances the profile of institutions as a result of improved quality of research, teaching and learning methodologies.
- Make Students industry ready with field exposures.

**Benefits to BITS, Bhubaneswar :**

- Utilization of well equipped Laboratories for Quality Control of Work.
- Fulfilling the requirement of Social Responsibility of the Organization.
- Opportunities for increased collaboration with govt. organizations.
- BITS can hire trained manpower from the Institution.

This MOU will be valid for Two years from the date of signing and can be extended up to one years. Both parties shall take all reasonable steps to ensure the successful completion of the collaboration.

### 3. Mutual Obligation:

- Both parties shall maintain confidentiality about any information, course material, plans, discussions, strategies or any other material, which shall be deemed to be confidential and marked accordingly. Any information, course material or the like in the public domain shall not be part of this commitment.
- Both the parties will designate a representative from its side who will be the primary point of contact on behalf of that party
- Both parties shall maintain record of execution of the implementation Plan which includes various activities like meetings, developing strategies, defining goals and deliverables.

### AMENDMENT TO THE MOU

No amendment or modification of this MOU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to an amendment of this agreement. The modification/ changes shall be effective from the date on which they are made/ executed unless otherwise agreed to.

### ARBITRATION

In the events of any dispute or difference between the parties hereto, such disputes or differences shall be resolved amicably by mutual discussion of the Principal/Directors of both the Organizations.

Now, therefore, for and in consideration of the foregoing premises the parties have signed the Memorandum of Understanding on 24/10/2024.
